NOTIFICATION OF INTENT

Italy intends to advertise for International Competitive Bidding the following works within the framework of the NATO Security Investment Programme.

1. INTERNATIONAL COMPETITIVE BIDDING (ICB) C.E. 270712.
2. CP/SERIAL: CP 3A 0011 / SERIAL 1996/3AF50069-0
3. LOCATION: AVIANO A.B. (PORDENONE).
4. PROJECT: EXTEND EXISTING WAREHOUSE.
5. FORESEEN PERIOD OF PERFORMANCE: **2013,2014,2015.**
6. DESCRIPTION OF WORKS:

Extension and restoration of three existing warehouses;

SITE 1. Enlargement of an existing warehouse building no. 1029 by the construction of the two new bodies in concrete, to be put beside the right and the left side.

SITE 3. Refurbishment of the building no. 1461/Hangar no. 5 consisting in repair of damaged steel structure, demolition and reconstruction of the existing bodies made of brick and concrete.

SITE 4. Refurbishment of the building no. 1463/Hangar no. 6 consisting in repair of damaged steel structure, demolition and reconstruction of the existing bodies made of bricks and concrete.

10. TYPE OF BIDDING: One step procedure. Contract will be awarded to the lowest compliant bidder: method and requirement of the tender will be detailed in the invitation for bid.

- 11.1 Firms who do not have place of business in any of the member countries are excluded from ICB.
- 11.2 For the participation in the competitive bidding only such firms are eligible who have properly been screened and who have been licensed to execute NATO contracts.
- 11.3 Foreign Firms shall send their request of participation to MOD Italy through:
- The Embassy of origin in Italy or the NATO Delegation/Mission of the country of origin in Bruxelles.
